A reminder that the Passover memorial is for those who have been immersed into Yahshua's Name, Exodus 12:43-45: "And Yahweh said unto Moses and Aaron, This [is] the ordinance of the Passover: There shall no stranger eat thereof. But every man's servant that is bought for money, when you have circumcised him, then shall he eat thereof. A foreigner and an hired servant shall not eat thereof." We plan to Webcast the Memorial service on live streaming video for those who are homebound.

Which Law(s) of Moses Would Rebuild the National Economy?

The daily payment of wages allowed the Israelite laborer to meet his immediate needs (Lev 19:13; Deut 24:14-15). This law would trigger a daily injection of new cash into the economy. Cancellation of debt every 7 years (Deut. 15:1-2) would give the poor much-needed relief. With today's complex inheritance tax laws and disadvantaged minorities emerging into the middle class, many are appalled to learn that their children could be penalized to build on the success of their parents. Yahweh requires inheritance to stay within the family (Lev 25:10; Deut 19:14). Personal generosity to the poor has a lasting legacy of effectiveness in the Jewish community, among whom Yahweh's laws of charity resulted in very low poverty rates (Deut 15:7-8). Answer: All of the above.
